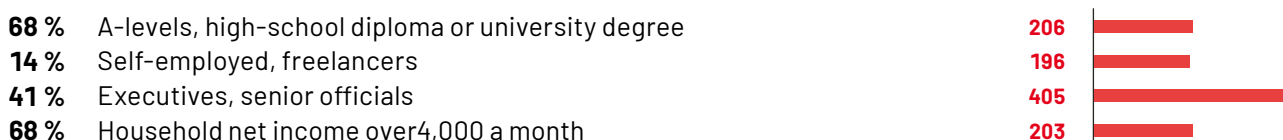
Gender and age

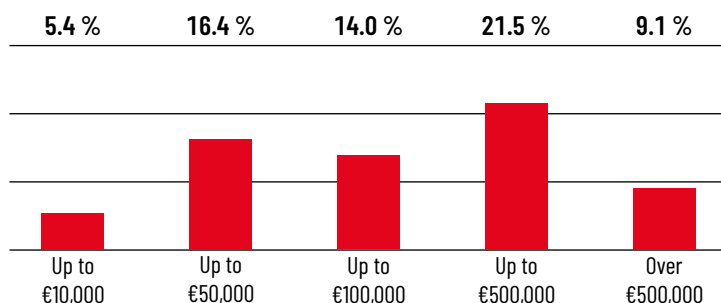

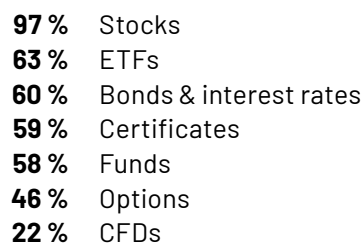

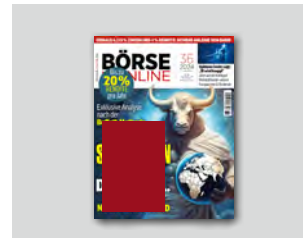
